Authorization for Payment of Dues - Electronic Bank Draft or Monthly Credit Card

I authorize GreatLife KC and the financial institution named on the attached check or deposit slip to deduct, the amount of my monthly dues and any charges made to my membership account, from the account identified on the attached check or deposit slip. I understand my automatic payment will be deducted on the 15th day of each month. If the 15th falls on a weekend or bank holiday, the deduction will be drafted on the next business day following the 15th. Changes must be received prior to the 1st business day of any given month in order to be processed for that month's payment. Canceling a bank draft does not cancel a membership or cancel charges accrued on the membership account. In the event that a bank draft is revoked or an account is closed and new bank information is not received, the membership will be transferred to the "annual payment" option and the remaining amount due under the terms of the Application will be owed. Early termination (prior to April 1 of any given year) will only be accepted in the event of a member who passes away or a member who has accepted military assignment out of the area for more than 30 days.
